ORDER REGARDING THE FOUNDING AND OPERATION OF THE NATIONAL MENTAL HEALTH CENTRE WITHIN THE BUCHAREST HEALTH RESEARCH AND DEVELOPMENT NATIONAL INSTITUTE

Considering the provisions of art. 10 from Annex no. 1 "Regulations for the organization and operation of the Health Research and Development National Institute" upon the Government Decision no. 1329/2002 regarding the founding and operation of the Bucharest Health Research and Development National Institute;

Seeing the proposal of the Board of Directors and the Bucharest Health Research and Development National Institute

Given the Medical Assistance, Remuneration and Medical Structures General Directorate's approval report no. ____/ ____;

On the grounds of the provisions of the Government Decision no. 168/2005 regarding the organization and operation of the Ministry of Health, with the subsequent amendments and additions;

Issued this

ORDER

Art.1

As of the date of this order, the Mental Health National Center is founded as a structure lacking legal personality, within the Bucharest Health Research and Development National Institute,

Art.2

The Mental Health National Center is a technical and methodological forum for promoting, monitoring and evaluating the activities from the medical health field, necessary for the Ministry of Health to elaborate mental health policies.

Art.3

The Mental Health National Center has the following main responsibilities in the mental health field:

Consultancy and technical assistance in the field of mental health policies

Consultancy and technical assistance in the development of the new mental health services

Consultancy and technical assistance in the training of the personnel working in the national mental health network.

Development of competences in the organization and management of mental health services

Organization of the elaboration and dissemination of the practice guides in the mental health field

Collection of data in the mental health field

Monitoring and evaluation of mental health services

Compiling and maintaining the national psychiatry register

Art.4

In order for the National Mental Health Center to carry out this activity, the job record of the Bucharest Health Research and Development National Institute is added to positions.

Art.5

The organizational structure of the Bucharest Health Research and Development National Institute is adequately modified, according to the annex representing an integral part of this order.

Art.6

(1) The founding of the Mental Health National Center is ensured by the Health Research and Development National Institute, from its own funds obtained based on the research, analysis, evaluation and monitoring activities typical for the mental health segment, stipulated in the national health programmes financed from the Ministry of Health budget.

(2) The activities stipulated in par. (1) are carried out by means of direct negotiation, based on contracts, concluded between the Ministry of Health and the Health Research and Development National Institute.

(3) Health Research and Development National Institute will include in the income and expenditure budget the modifications resulting from the founding and operation of the Mental Health National Center and submit it for endorsement and approval, according to the legal provisions in force.

(4) Within 30 days from this order's enforcement date, the Health Research and Development National Institute will conclude the service contract with the Ministry of Health regarding the research, analysis, evaluation and monitoring activities based on the proposals submitted for approval by the General Directorate for Medical Assistance, Remuneration and Medical Structures, as the national coordinator of the Programme for preventing and controlling non-transmissible diseases.

Art. 7

The Health Research and Development National Institute, the General Directorate for Medical Assistance, Remuneration and Medical Structures, the other involved specialized directorates from the Ministry of Health will fulfill the provisions of this order.
